



## NOTICE OF PROPOSED ACTION

The Administrator, Division of Environmental Protection, Carson City, Nevada is issuing the following notice of proposed action under the Nevada Revised Statutes and/or the Clean Water Act, where applicable. The Administrator has received an application for a Groundwater Discharge, permit number NS0095007 from the following applicant:

### **Permit NS0095007, WILDCREEK GOLF COURSE:**

The Reno-Sparks Convention and Visitors Authority (RSCVA) has applied for renewal of their reuse permit which allows irrigation of the Wildcreek Golf Course using tertiary treated, denitrified, and disinfected reclaimed water, being of Category B bacteriological quality per Nevada Administrative Code (NAC) 445.276, as supplied by the Truckee Meadows Water Reclamation Facility (TMWRF) (NS2003506) for the Wildcreek Golf Course, located at 3500 Sullivan Lane, in Sparks, Washoe County, Nevada. The irrigation reuse is via spray and drip irrigation on turf grass and other plants, along with pond maintenance, and is conducted in accordance with conditions specified in this permit and the approved Reclaimed Water Management Plan (RWMP) required by the Bureau of Water Pollution Control as a condition of the permit.

On the basis of preliminary review of the requirements of the Nevada Revised Statutes, as amended, and implementing regulations, the Administrator proposes to issue Permit NS0095007 to discharge for a five (5) year period, subject to certain effluent limitations.

Persons wishing to comment upon or object to the proposed determinations by the Administrator regarding permit issuance should submit their comments or request, in writing, hand delivered or postmarked no later than 5:00 P.M. on 02/15/2025, either in person or by mail to:

The request must be filed within the comment period and must indicate the interest of the person filing the request and the reasons why a hearing is warranted. All comments or objections received within the thirty (30) day period will be considered in the formulation of final determination(s) regarding the application. If written comments indicate a significant degree of public interest in the proposed permit, the Administrator shall hold a public hearing. A public notice of such hearing will be issued not less than thirty (30) days prior to the hearing date.

If no hearing is held and the determinations of the Administrator are substantially changed from the tentative determinations, the Administrator will give public notice of the revised determinations. Additional comments and objections will be considered at that time.

A public hearing on the proposed determination can be requested by the applicant, any affected State, any affected interstate agency, the Regional Administrator of EPA Region IX or any interested agency, person or group of persons. The request must be filed within the comment period and must indicate the interest of the person filing the request and the reasons why a hearing is warranted. Any public hearing determined by the Administrator to be held must be conducted in the geographical area of the proposed discharge or any other area the Administrator determined to be appropriate. All

public hearings must be conducted in accordance with NAC 445A.238.
