NOTICE OF PROPOSED ACTION

The Administrator, Division of Environmental Protection, Carson City, Nevada is issuing the following notice of proposed action under the Nevada Revised Statutes and/or the Clean Water Act, where applicable. The Administrator has received an application for a Groundwater Discharge, permit number NS2019514 from the following applicant:

NYE COUNTY SCHOOL DISTRICT 601 E. CALVADA BLVD. PAHRUMP, NV - 89048

Permit NS2019514, PAHRUMP VALLEY HIGH SCHOOL:

The Permittee, Nye County School District, has applied for the renewal of Permit NS2019514 for the Pahrump Valley High School (PVHS), at 501 E. Calvada Boulevard, in Pahrump, being within Nye County, Nevada. The PVHS has three sports fields totaling approximately 3.4 acres; the fields consists of Bermuda grass. The Permittee proposes to continue to irrigate the fields with reclaimed water obtained from "The Property" (permit NS2005503), formerly known as the Willow Creek Golf Course. The Property is supplied reclaimed water by the Great Basin Water Company's UICN Wastewater Treatment Plant (WWTP) #3 (permit NS0089063). The reclaimed water is tertiary treated, denitrified, and disinfected to meet Category B bacteriological requirements per Nevada Administrative Code 445A.2764.

On the basis of preliminary review of the requirements of the Nevada Revised Statutes, as amended, and implementing regulations, the Administrator proposes to issue Permit NS2019514 to discharge for a five (5) year period, subject to certain effluent limitations.

Persons wishing to comment upon or object to the proposed determinations by the Administrator regarding permit issuance should submit their comments or request, in writing, hand delivered or postmarked no later than 5:00 P.M. on 11/10/2025, either in person or by mail to:

The request must be filed within the comment period and must indicate the interest of the person filing the request and the reasons why a hearing is warranted. All comments or objections received within the thirty (30) day period will be considered in the formulation of final determination(s) regarding the application. If written comments indicate a significant degree of public interest in the proposed permit, the Administrator shall hold a public hearing. A public notice of such hearing will be issued not less than thirty (30) days prior to the hearing date.

If no hearing is held and the determinations of the Administrator are substantially changed from the tentative determinations, the Administrator will give public notice of the revised determinations. Additional comments and objections will be considered at that time.

A public hearing on the proposed determination can be requested by the applicant, any affected State, any affected interstate agency, the Regional Administrator of EPA Region IX or any interested agency, person or group of persons. The request must be filed within the comment period and must indicate the interest of the person filing the request and the reasons why a hearing is warranted. Any public hearing determined by the Administrator to be held must be conducted in the geographical area of the proposed discharge or any other area the Administrator determined to be appropriate. All

public hearings must be conducted in accordance with NAC 445A.238.
