



NOTICE OF PROPOSED ACTION

The Administrator, Division of Environmental Protection, Carson City, Nevada is issuing the following notice of proposed action under the Nevada Revised Statutes and/or the Clean Water Act, where applicable. The Administrator has received an application for a Manufacturing, Commercial, Mining and Silvicultural facility that discharges NON-PROCESS Wastewater, permit number NV0022781 from the following applicant:

Permit NV0022781, TOMIYASU RESIDENCE:

The Permittee, the Tomiyasu Residence, has applied for the renewal of their National Pollutant Discharge Elimination System Permit NV0022781, the residence is located at 3030 Tomiyasu Lane, in the Paradise portion of Las Vegas, within Clark County, Nevada. This residence is located on the north side of Duck Creek, where it intersects Tomiyasu Lane. The property consists of a private residence and several other buildings, including a sports complex. The sports complex basement uses a sump to intercept shallow groundwater which would otherwise flood the complex. A pump discharges the intercepted groundwater to Duck Creek at a point approximately 200 feet west of the southeast corner of the property. Duck Creek flows to the Las Vegas Wash. The Permittee proposes to continue to discharge intercepted groundwater to the Las Vegas Wash via Duck Creek.

On the basis of preliminary review of the requirements of the Nevada Revised Statutes, as amended, and implementing regulations, the Administrator proposes to issue Permit NV0022781 to discharge for a five (5) year period, subject to certain effluent limitations.

Persons wishing to comment upon or object to the proposed determinations by the Administrator regarding permit issuance should submit their comments or request, in writing, hand delivered or postmarked no later than 5:00 P.M. on 04/28/2026, either in person or by mail to:

The request must be filed within the comment period and must indicate the interest of the person filing the request and the reasons why a hearing is warranted. All comments or objections received within the thirty (30) day period will be considered in the formulation of final determination(s) regarding the application. If written comments indicate a significant degree of public interest in the proposed permit, the Administrator shall hold a public hearing. A public notice of such hearing will be issued not less than thirty (30) days prior to the hearing date.

If no hearing is held and the determinations of the Administrator are substantially changed from the tentative determinations, the Administrator will give public notice of the revised determinations. Additional comments and objections will be considered at that time.

A public hearing on the proposed determination can be requested by the applicant, any affected State, any affected interstate agency, the Regional Administrator of EPA Region IX or any interested agency, person or group of persons. The request must be filed within the comment period and must indicate the interest of the person filing the request and the reasons why a hearing is warranted. Any public hearing determined by the Administrator to be held must be conducted in the geographical

area of the proposed discharge or any other area the Administrator determined to be appropriate. All public hearings must be conducted in accordance with NAC 445A.238.
