NOTICE OF PROPOSED ACTION

The Administrator, Division of Environmental Protection, Carson City, Nevada is issuing the following notice of proposed action under the Nevada Revised Statutes and/or the Clean Water Act, where applicable. The Administrator has received an application for a Groundwater Discharge, permit number NS2021506 from the following applicant:

Permit NS2021506, NEVADA DEPARTMENT OF TRANSPORTATION - ALAMO:

The Permittee, Nevada Department of Transportation (NDOT), operator of the Nevada Department of Transportation Alamo Maintenance Station (NDOT Alamo MS), located at 394 S US Highway 93, Alamo, Nevada, is renewing their Groundwater Discharge Permit NS2021506. Permittee is authorized to discharge wastewater, collected from culverts and roadway utility drainage areas, via their hydro service equipment trucks, into the concrete-lined decant basin located at the NDOT Alamo MS. The hydro cleaning VAC trucks use a water-and-suction-reclaim system to clean culverts and roadway utility drainage areas that are a part of the NDOT highway maintenance system. The truck reclaims the water and debris through suction into a holding tank, then transported and discharged into the decant basin. The waste debris are removed from the decant basin and transported to a landfill for disposal.

On the basis of preliminary review of the requirements of the Nevada Revised Statutes, as amended, and implementing regulations, the Administrator proposes to issue Permit NS2021506 to discharge for a five (5) year period, subject to certain effluent limitations.

Persons wishing to comment upon or object to the proposed determinations by the Administrator regarding permit issuance should submit their comments or request, in writing, hand delivered or postmarked no later than 5:00 P.M. on 10/15/2026, either in person or by mail to:

The request must be filed within the comment period and must indicate the interest of the person filing the request and the reasons why a hearing is warranted. All comments or objections received within the thirty (30) day period will be considered in the formulation of final determination(s) regarding the application. If written comments indicate a significant degree of public interest in the proposed permit, the Administrator shall hold a public hearing. A public notice of such hearing will be issued not less than thirty (30) days prior to the hearing date.

If no hearing is held and the determinations of the Administrator are substantially changed from the tentative determinations, the Administrator will give public notice of the revised determinations. Additional comments and objections will be considered at that time.

A public hearing on the proposed determination can be requested by the applicant, any affected State, any affected interstate agency, the Regional Administrator of EPA Region IX or any interested

agency, person or group of persons. The request must be filed within the comment period and must indicate the interest of the person filing the request and the reasons why a hearing is warranted. Any public hearing determined by the Administrator to be held must be conducted in the geographical area of the proposed discharge or any other area the Administrator determined to be appropriate. All public hearings must be conducted in accordance with NAC 445A.238.
