



## **Notice of Public Workshop Proposed Regulation Revisions R133-24 Bureau of Safe Drinking Water**

The Nevada Division of Environmental Protection (NDEP), Bureau of Safe Drinking Water (BSDW), is proposing to adopt regulations amendments in the following sections of Nevada Administrative Code (NAC) 445A: *Water Quality, Treatment of Water: Groundwater, and Design, Construction, Operation and Maintenance*.

The proposed amendments include removal of redundant language in the Water Quality section, removal of the requirement that privately owned non-community public water systems submit a Preliminary Engineering Report (PER) prior to submittal of design plans, clarification of regulations in the Treatment of Groundwater section, modifications to the design review fee of water treat facilitates, inclusion of an organization for certified backflow prevention assembly testers, modifications to treatment facilities and their design to function safely and efficiently, and modification to the materials allowed for water storage facilities and standard updates.

A public workshop to present and hear public comment regarding R133-24 will be held on **Thursday, September 26, 2024, 9am-10am**. The meeting will be held in-person at NDEP offices in Carson City and Las Vegas at the addresses below:
