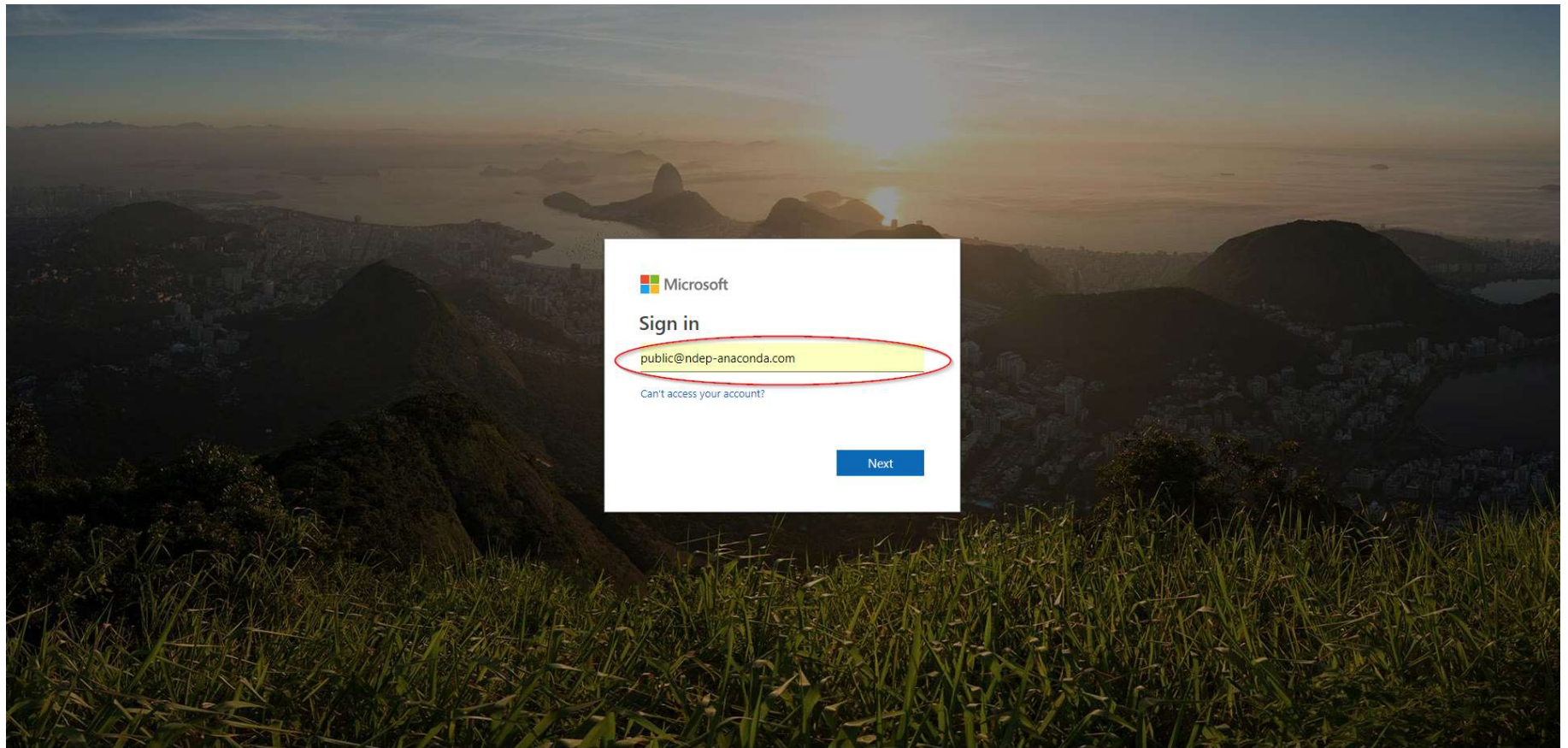


SOP for accessing NDEP Anaconda Public Records Library

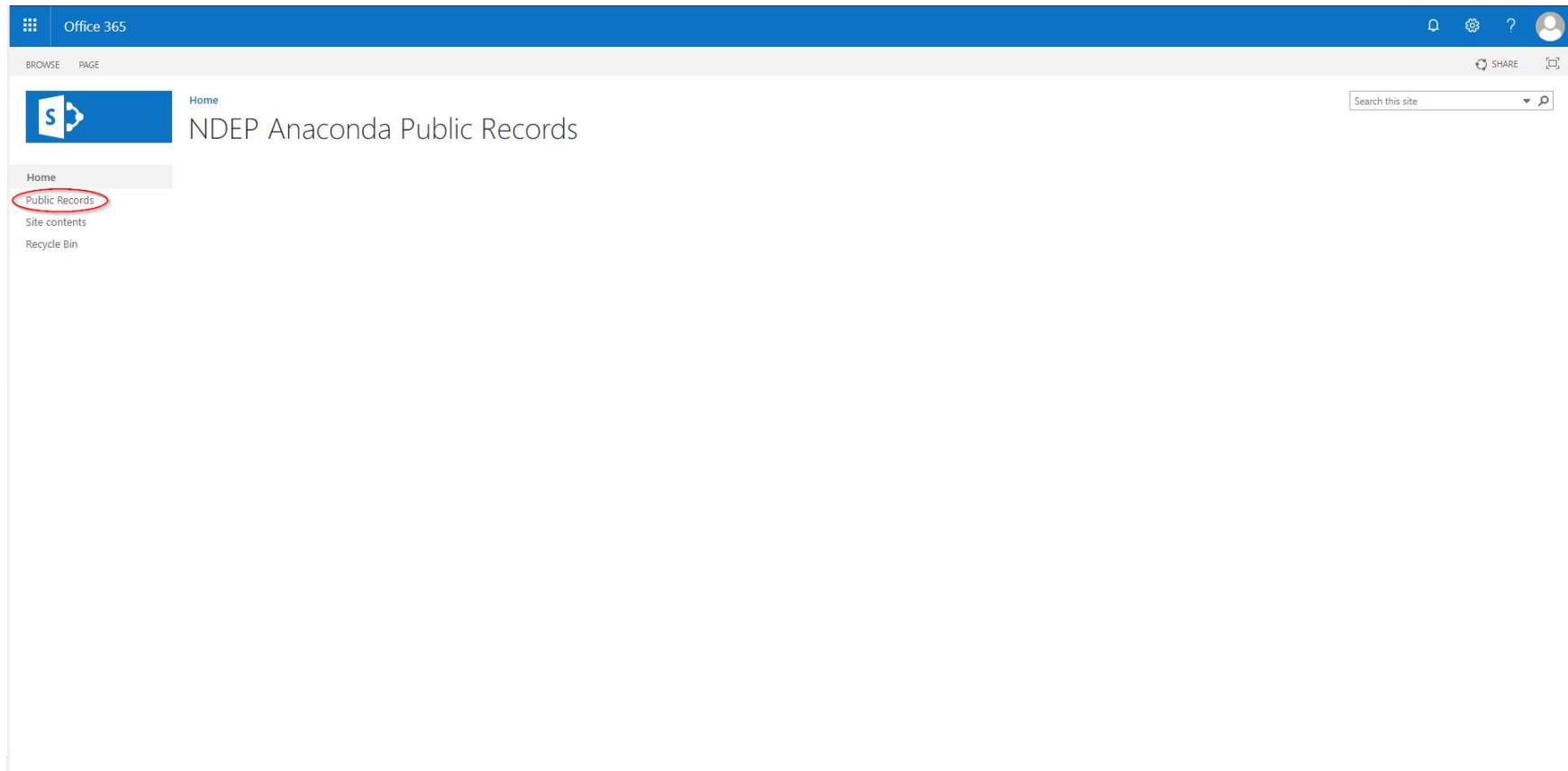
1. Navigate to the [NDEP Anaconda SharePoint site](#) and log-in using the public access credentials

Username: public@ndep-anaconda.com

Password: C0pper12#



2. Once logged in, access the Public Records library by clicking on the link on the left side of the screen.
