PUBLIC NOTICE

Pursuant to Nevada Revised Statutes (NRS) Chapter 445B, the Nevada Administrative Code (NAC) Chapter 445B, and the Clean Air Act, the Nevada Division of Environmental Protection is issuing the following Notice of Proposed Action.

The Director received an application for a revision of Mercury Operating Permit to Construct, AP1041-2254 (FIN A0387) from the following applicant:

Marigold Mining Company – Marigold Mine is located 4 miles south of I-80 at the Valmy Interchange (Exit 216). The project is located in all or portions of Sections 1 and 2, Township 32N, Range 42E, M.D.B.&M, Sections 4-6, Township 32N, Range 43E, M.D.B.&M, Sections 1, 11-13, 23-25, 35, 36, Township 33N, Range 42E, M.D.B.&M, Sections 4-10, 16-21, 28-33, Township 33N, Range 43E, M.D.B.&M, Section 36, Township 34N, Range 42E, M.D.B.&M, and Sections 19, 20, 28, 30-33, Township 34N, Range 43E, M.D.B.&M.

Marigold Mining Company has submitted an application to revise their Mercury Operating Permit to Construct (MOPTC) Permit No. 1041-2254 for the Marigold Mine. The application includes the following proposed changes: updating the control equipment list to include an existing heater (HE-001) and demister (DM-001) as gas conditioning units for the Carbon Kiln (System 01, TU4.001), and revising the wet scrubber control unit (WS-001) water flow rate from 50 gallons per minute to 40 gallons per minute.

On the basis of the preliminary review and the requirements of the NRS, the NAC and the Clean Air Act, the Director is hereby announcing his intent to issue the proposed Mercury Operating Permit to Construct based on a review of the information submitted. A copy of this document, the draft permit, and the Director's Review will be available for public inspection at <http://ndep.nv.gov/posts>.
