Pursuant to Nevada Revised Statutes (NRS) Chapter 445B, the Nevada Administrative Code (NAC) Chapter 445B, and the Clean Air Act, the Nevada Division of Environmental Protection is issuing the following Notice of Proposed Action.

The Director received an application for a new Class I Air Quality Operating (Title V), AP1041-4681 (FIN A2214) from the following applicant:

Solidus Resources, LLC 2000 Vassar Street, PO Box 11340 Reno, NV 89510

Solidus Resources, LLC – Spring Valley Mine Project is located approximately 20 miles northeast of Lovelock, Nevada, and east of I-80 exit 119 on Unionville Road. The project is located in all or portions of Sections 24 through 28 and 33 through 36, Township 29 N, Range 34 E; Sections 19 through 21 and 28 through 32, Township 29 N, Range 35 E; Sections 1 through 4, Township 28 N, Range 34 E; and Sections 4 through 6, Township 28 N, Range 35 E, M.D.B.&M.

Solidus Resources, LLC proposes to operate an open pit, heap leach, and precious metals recovery mining operation. The site will include crushing and screening, cyanide heap leach, and refinery operations.

On the basis of the preliminary review and the requirements of the NRS, the NAC and the Clean Air Act, the Director is hereby announcing his intent to issue the proposed Class I Air Quality Operating Permit based on a review of the information submitted. The application, Director's Review, proposed permit, any comments received, and other relevant information may be copied at the above address or copies may be obtained by written request to the above address. Written comments or objections will be received at NDEP, above address, until **December 31, 2025**, and will be retained and considered prior to final action on the proposed Class I Air Quality Operating Permit.

The BAPC will submit the proposed Class I Air Quality Operating Permit to the U.S. Environmental Protection Agency (EPA) for a 45-day review period on the same day the 30-day public comment period commences. If the BAPC has not addressed any received comments in a satisfactory manner, and the EPA does not object to the Class I Air Quality Operating Permit during its review period, the public may submit a petition to the EPA requesting to reconsider issuance within 60 days after the expiration of the 45-day review period.
