## **PUBLIC NOTICE**

Pursuant to Nevada Revised Statutes (NRS) Chapter 445B, the Nevada Administrative Code (NAC) Chapter 445B, and the Clean Air Act, the Nevada Division of Environmental Protection is issuing the following Notice of Proposed Action.

The Director received an application for a new Mercury Operating Permit to Construct, AP1041-4682 (FIN A2214) from the following applicant:

Solidus Resources, LLC 2000 Vassar Street, P.O. Box 11340 Reno, Nevada 89510

Solidus Resources, LLC – Spring Valley Mine Project is located 21 miles northeast of Lovelock, Nevada on Lovelock-Unionville Road. The project is located in all or portions of Sections 24-28 and 33-36, Township 29N, Range 34E, M.D.B.&M; Sections 19-21 and 28-32, Township 29N, Range 35E, M.D.B.&M; Sections 1-4, Township 28N, Range 34E, M.D.B.&M; and Sections 4-6, Township 28N, Range 35E, M.D.B.&M.

Solidus Resources, LLC submitted an application for a new MOPTC for a precious metal mining operation at the proposed Spring Valley Mine Project, which will primarily produce gold. The new facility will include the following thermal mercury emitting equipment: a carbon kiln (TU4.001), an electrowinning circuit having electrowinning cells (TU4.002), a barren tank (TU4.003), an eluant tank (TF4.004), a retort (TU4.005), and a furnace (TU4.006).

On the basis of the preliminary review and the requirements of the NRS, the NAC and the Clean Air Act, the Director is hereby announcing his intent to issue the proposed Mercury Operating Permit to Construct based on a review of the information submitted.
