PUBLIC NOTICE

Pursuant to Nevada Revised Statutes (NRS) Chapter 445B, the Nevada Administrative Code (NAC) Chapter 445B, and the Clean Air Act, the Nevada Division of Environmental Protection is issuing the following Notice of Proposed Action.

The Director received an application for a revision of Class II Air Quality Operating Permit, AP1442-0823.05 (FIN A0432) from the following applicant:

CAS Development Company LLC

Dayton, Nevada 89403

CAS Development Company LLC – Dayton Aggregates is located in Dayton. From Carson City, drive east on HWY50 towards Dayton. Turn right on Dayton Valley Road and right again on Ricci Road. The project is located in all or portions of Sections 23 and 24, Township 16N, Range 21E, M.D.B.&M.

CAS is proposing to edit unit descriptions for PF1.001, PF1.002, PF1.004 through PF1.010, PF1.012, PF1.014, PF1.018, PF1.020 through PF1.022, PF1.027 through PF1.030, PF1.035 and PF1.036, PF1.039, PF1.040, PF1.045 through PF1.047, PF1.050 through PF1.052, and PF1.055, while removing PF1.003, PF1.011, PF1.013, PF1.015 through PF1.017, PF1.019, PF1.023 through PF1.026, PF1.031 through PF1.034, PF1.037, PF1.038, PF1.041 through PF1.044, PF1.048, PF1.049, PF1.053, PF1.054, and PF1.056. CAS is also adding new units PF1.057 through PF1.076, S2.001, IA1.002, and IA1.003.

On the basis of the preliminary review and the requirements of the NRS, the NAC and the Clean Air Act, the Director is hereby announcing his intent to issue the proposed Class II Air Quality Operating Permit based on a review of the information submitted.
