PUBLIC NOTICE

Pursuant to Nevada Revised Statutes (NRS) Chapter 445B, the Nevada Administrative Code (NAC) Chapter 445B, and the Clean Air Act, the Nevada Division of Environmental Protection is issuing the following Notice of Proposed Action.

The Director received an application for a revision of Class II Air Quality Operating Permit, AP3273-4261 (FIN A0140) from the following applicant:

Pyramid Materials DBA American Ready Mix
147 East Greg Street
Sparks, NV 89431

Pyramid Materials DBA American Ready Mix – Fernley Ready Mixed Concrete is located at 345 Winston Street, Fernley, Nevada. The project is located in all or portions of Section 11, Township 20 N, Range 24 E, M.D.B.&M.

The facility operates a ready-mix concrete plant in Fernley, Nevada. Sand and aggregate from storage piles are transferred to a hopper, which is then conveyed to an elevated storage bin, and then to a weigh hopper before dropping into awaiting mix trucks. Cement and fly ash are delivered by trucks and pneumatically transferred to silos. The silo's unload to a weigh hopper before being transferred to the awaiting mix trucks. This permitting action will increase production throughputs, increase operating hours, revise the control efficiencies for the water spray controls, revise the emission limits, and replace two small water heaters with a larger water heater that will be permitted as a new system.

On the basis of the preliminary review and the requirements of the NRS, the NAC and the Clean Air Act, the Director is hereby announcing his intent to issue the proposed Class II Air Quality Operating Permit based on a review of the information submitted.
