## **PUBLIC NOTICE**

Pursuant to Nevada Revised Statutes (NRS) Chapter 445B, the Nevada Administrative Code (NAC) Chapter 445B, and the Clean Air Act, the Nevada Division of Environmental Protection is issuing the following Notice of Proposed Action.

The Director received applications for a renewal and minor revision of Class I Air Quality Operating Permit (AQOP) (Title V), AP3274-1329.04 (FIN A0367) from the following applicant:

Graymont Western US Inc. – Pilot Peak Plant P.O. Box 2520 Wendover, NV 89883

Graymont Western US Inc. – Pilot Peak Plant is located approximately 12 miles northwest of Wendover, Nevada. The project is located in all or portions of Sections 10, 12 through 16, 21 through 28 and 34 through 36, Township 34N, Range 68E; Sections 30 and 31, Township 34N, Range 69E M.D.B.&M.

Graymont Western US Inc. is proposing to renew and revise their AQOP. For the revision, Systems 41 - 44 emission units S2.190 - S2.193 were removed and replaced by S2.204 - S2.207. Also, an emergency diesel fired generator, S2.208, was added as System 59.

On the basis of the preliminary review and the requirements of the NRS, the NAC and the Clean Air Act, the Director is hereby announcing his intent to issue the proposed Class I Air Quality Operating Permit based on a review of the information submitted. The application, Director's Review, proposed permit, any comments received, and other relevant information may be copied at the above address or copies may be obtained by written request to the above address. Written comments or objections will be received at NDEP, above address, until **June 26, 2025**, and will be retained and considered prior to final action on the proposed Class I Air Quality Operating Permit.

The BAPC will submit the proposed Class I Air Quality Operating Permit to the U.S. Environmental Protection Agency (EPA) for a 45-day review period on the same day the 30-day public comment period commences. If the BAPC has not addressed any received comments in a satisfactory manner, and the EPA does not object to the Class I Air Quality Operating Permit during its review period, the public may submit a petition to the EPA requesting to reconsider issuance within 60 days after the expiration of the 45-day review period.
