PUBLIC NOTICE

Pursuant to Nevada Revised Statutes (NRS) Chapter 445B, the Nevada Administrative Code (NAC) Chapter 445B, and the Clean Air Act, the Nevada Division of Environmental Protection is issuing the following Notice of Proposed Action.

The Director received an application for a revision of Class II Air Quality Operating Permit, AP3443-2616.03 (FIN A1056) from the following applicant:

Chart, Inc. 1995 Peru Drive McCarran, Nevada 89437

Chart, Inc. – McCarran Facility is located in the Tahoe Regional Industrial Complex in Storey County. The project is located in all or portions of Sections 2, 3, 10, and 11, Township 19 N, Range 22 E, M.D.B.&M.

In the Class II Revision application, Chart requested to make several updates to various emission units: S2.001 – increase spray paint and solvent throughput, and updated solvent usage from Amercoat 101 Thinner to both Amercoat 101 Thinner and Amercoat 65 Thinner. Remove time of day operating restrictions, to operate 24 hr/day 8760 hr/year. S2.002 – facility wide solvent use has changed to using acetone which is not a VOC emitting solvent. Chart requested to have this emission unit removed from the facility. S2.003 – remove operating restrictions and increase hours of operation to 24 hr/day, 8760 hr/year. S2.004 – increase the annual number of valves processed, use a grain loading factor of 0.002 gr/scf based on manufacture guarantee, and remove operating restrictions to increase operating hours to 24 hr/day, 8760 hr/year. S2.005 – updated the grain loading factor to 0.002 and remove the time-of-day operating restrictions to increase hours of operation to 24 hr/day and 8760 hr/year. System 5 – added 4 welding emission units, increased welding material used to 5,000 pounds and change monitoring and recordkeeping requirements from a weekly basis to a monthly basis of consumption.

On the basis of the preliminary review and the requirements of the NRS, the NAC and the Clean Air Act, the Director is hereby announcing his intent to issue the proposed Class II Air Quality Operating Permit based on a review of the information submitted. A copy of this document, the draft permit, and the Director's Review will be available for public inspection at http://ndep.nv.gov/posts.
