PUBLIC NOTICE

Pursuant to Nevada Revised Statutes (NRS) Chapter 445B, the Nevada Administrative Code (NAC) Chapter 445B, and the Clean Air Act, the Nevada Division of Environmental Protection is issuing the following Notice of Proposed Action.

The Director received an application for a renewal of Class I Air Quality Operating Permit (Title V), AP4911-2189.03 (FIN A0016) from the following applicant:

Nevada Gold Mines, LLC – Western 102 Power Plant is located approximately 25 kilometers east of Reno, NV at the Reno-Tahoe Industrial Complex. The project is located in all or portions of Sections 33 and 34, Township 20N, Range 22E, M.D.B.&M.

Nevada Gold Mines, LLC is proposing to renew their existing Class I AQOP in this permitting action. Nevada Gold Mines, LLC operates the Western 102 Power Plant facility, which consists of fourteen Wartsila 20V34SG four stroke lean-burn pipeline quality natural gas burning engines that turn generators to develop power. Additionally, the facility has a 170 hp Detroit Diesel Emergency Generator.

On the basis of the preliminary review and the requirements of the NRS, the NAC and the Clean Air Act, the Director is hereby announcing his intent to issue the proposed Class I Air Quality Operating Permit based on a review of the information submitted. A copy of this document, the draft permit, and the Director's Review will be available for public inspection at <http://ndep.nv.gov/posts>.

Persons wishing to comment regarding this proposed action, or to request a hearing pursuant to NRS 445B Air Pollution and NAC 445B Air Controls, should submit their comments or request in writing, either in person or by mail within thirty (30) days to:

The application, Director's Review, proposed permit, any comments received, and other relevant information may be copied at the above address or copies may be obtained by written request to the above address. Written comments or objections will be received at the Nevada Division of Environmental Protection, above address, until **April 20, 2026**, and will be retained and considered prior to final action on the proposed Class I Air Quality Operating Permit.

The BAPC will submit the proposed Class I Air Quality Operating Permit to the U.S. Environmental Protection Agency (EPA) for a 45-day review period on the same day the 30-day public comment period commences. If the BAPC has not addressed any received comments in a satisfactory manner, and the EPA does not object to the Class I Air Quality Operating Permit during its review period, the public may submit a petition to the EPA requesting to reconsider issuance within 60 days after the expiration of the 45-day review period.
