### PUBLIC NOTICE

Pursuant to Nevada Revised Statutes (NRS) Chapter 445B, the Nevada Administrative Code (NAC) Chapter 445B, and the Clean Air Act, the Nevada Division of Environmental Protection is issuing the following Notice of Proposed Action.

The Director received an application for a renewal of Class II Air Quality Operating Permit, AP5032-4186.01 (FIN A0154) from the following applicant:

Graymont Western US, Inc.

Graymont Western US, Inc. – Golconda Transload Facility is located in Golconda, Nevada. From the intersection of Morrison Ave and Manselle Dr, head north on Morrison Ave. After 0.2 miles, turn left onto Stanford St. After 0.4 miles, turn right to stay on Stanford St for another 404 ft. Then, continue onto Eden Valley Rd for about 0.9 miles. Turn right onto Mobley Ranch Road and continue until site is reached in about 0.3 miles. The project is located in all or portions of Section 28, Township 36N, Range 40E, M.D.B.&M.

This is an Administrative Renewal of Class II AQOP for Graymont Western US, Inc. – Golconda Transload Facility with Public Notice. The facility is located within 1,000 ft of a residential area. Graymont Western US Inc. operates a rail transloading terminal for the transfer of lime to silos and trucks.

On the basis of the preliminary review and the requirements of the NRS, the NAC and the Clean Air Act, the Director is hereby announcing his intent to issue the proposed Class II Air Quality Operating Permit based on a review of the information submitted.
