Director's Review and Preliminary Determination of Permit Issuance for

**Harrah's Lake Tahoe Hotel Casino
Lake Tahoe Hotel Casino
Douglas County, Nevada
July 30, 2025**

Harrah's Lake Tahoe Hotel Casino (Harrah's) submitted an application for a revised Class II Air Quality Operating Permit, AP7011-3688.01, FIN A0574, for the Lake Tahoe Hotel Casino facility in Douglas County, Nevada. The project is located at Hwy 50 and Stateline Ave., in Stateline, Nevada, in all or portions of Section 27, Township 13N, Range 18E, M.D.B.&M.

This permitting action revised the throughput and emissions of the gasoline storage tank.

The Nevada Division of Environmental Protection – Bureau of Air Pollution Control (BAPC) has reviewed the application for the above-referenced operating permit and has made a preliminary determination to issue the operating permit. The facility-wide Potential to Emit (PTE), including emissions from Non-Permit equipment are given in the table below.

Current emissions estimates indicate Harrah's is a <i>Class II source</i> , because the facility-wide PTE for any individual regulated pollutant is <i>less</i> than 100 tons per year.	<i>Lake Tahoe Hotel Casino Potential to Emit (PTE)</i>

The project is located in Air Quality Hydrographic Area (HA) 90 of the Lake Tahoe Basin. HA 90 is not a triggered basin for an increment analysis. Harrah's is subject to 40 CFR Part 60 Subpart Dc, 40 CFR Part 63 Subpart CCCCCC, and 40 CFR Part 63 Subpart ZZZZ.

Air dispersion modeling conducted by the applicant and the Nevada Division of Environmental Protection – Bureau of Air Quality Planning (BAQP) demonstrates that continued operation of Harrah's, will not violate any air quality standard.

Harrah's must comply with all State and Federal air quality requirements and all conditions established within the proposed draft Class II Air Quality Operating Permit.
