The Nevada Division of Environmental Protection (NDEP) is proposing regulations that will amend Nevada Administrative Code (NAC) 445B. Permanent Regulation R077-24 (P2024-06): The NDEP is proposing to repeal Nevada Administrative Code (NAC) 445B.22087, 445B.3621, 445B.3639, 445B.3645, 445B.3651, 445B.3653, 445B.3669, and 445B.3673; and is proposing amendments to NAC 445B.281, 445B.3633, 445B.3647, 445B.3659, 445B.3663, 445B.3667, 445B.3671, 445B.3675, 445B.3677, and 445B.3679. The purpose of the proposed amendments is to repeal regulations that no longer serve a purpose for achieving the intents and purposes of NRS 445B.110 to NRS 445B.640, inclusive.

Permanent Regulation R119-24 (P2024-02): The NDEP is proposing to amend NAC 445B.221 to adopt applicable federal rules promulgated since the State regulation was last updated as of March 2022. This is a routine activity. The update includes rulemakings under 40 CFR Part 51, 60, 61 and 63.

Permanent Regulation R120-24 (P2024-04): NDEP is proposing to amend NAC 445B.592(3). This regulation will reduce the need to inspect new motor vehicles until the fourth registration of the vehicles, instead of the third registration.
