A non-refundable fee in the amount of **\$100.00** <u>must</u> accompany this application. NDEP only accepts check or money order mailed in or taken in person. No credit cards are accepted. Applications without the non-refundable fee will not be reviewed. The fee paid is good for the life of the application which is two years. Please make checks payable to NDEP. Please be aware that checks returned by the bank without payment will result in a letter from the State indicating that you will have fourteen (14) days from the date of the letter to make payment of the full amount of the check plus a \$25.00 returned check charge (NAC 353C.400). In addition, a hold will be placed on your file until adequate payment is received.

IMPORTANT INFORMATION

- The NDEP has six (6) weeks after receipt of a complete application to determine eligibility for renewal.
- 2. If approved, you will be certified for an additional two years from the date of your certificate expiration date.
- 3. If your certification lapses, you cannot legally continue to provide services as an Underground Storage Tank Tester in the State of Nevada. **THERE IS NO GRACE PERIOD!**
