The proposed revisions to NAC 590 will provide the groundwork for the **administration of a grant program for Underground Storage Tank (UST) owners/operators and will also provide for a technical assistance program for UST owners/operators.** The grant program is to offset costs for UST owners/operators with a financial need who must upgrade his/her UST system to comply with recent UST regulation changes that will go into effect October 2018.
