Undergoing Source Stabilization	1/2 the renewal fee of processing rate
Post Closure Monitoring	1/4 the renewal fee of processing rate <u>unless</u> in post closure monitoring prior to December 31, 2025.

Modification Fee Schedule

Modification Type	Fee
Preapplication Review	1/4 the renewal fee of proposed processing rate
Major Modification	Equal to the renewal fee
Minor Modification	1/2 the renewal fee to a maximum of \$10,000
Engineering Design Change (EDC)	\$1,000
