TEMPORARY PERMIT – BULK SAMPLE/CLOSED FACILITY EXPLORATION APPLICATION INSTRUCTIONS

PROCEDURES FOR FILING - A form fill version of the application is available at the Bureau of Mining Regulation and Reclamation (BMRR) website at [Regulation Branch Applications and Fees](#). Additional information sufficient to describe and explain the proposed activity must be included with the completed form, Nevada Administrative Code (NAC) 445A.394. Contents of the supporting information are detailed in the regulations governing temporary permits, NAC 445A.390 through 445A.447.

Initial characterization of the closed facility may not be needed for issuance of the temporary permit. Contact BMRR to discuss the proposed activities prior to filing the application.

SIGNATURE ON APPLICATION - The permit application must be signed by the owner or, for partnership or corporation, an executive officer whose name appears in Part 1. If the owner does not operate the facility then the operator or his designated agent must also sign the application, NAC 445A.394.

USE OF INFORMATION - All information contained in this application will, upon request, be made available to the public for inspection and copying.

APPLICABILITY – This application applies for a bulk sample or/and exploration activities and bulk sampling on closed process components, which are not covered under a Water Pollution Control Permit.

A temporary permit may be issued for a 180-day maximum period of time, pursuant to Nevada Revised Statutes (NRS) 445A.485, after which time the process component shall be reclaimed or the operator/owner shall have applied for and received a five (5) year Water Pollution Control Permit, NRS 445A.495. A \$350.00 fee is due at the time of application, NAC 445A.232.

CLOSED FACILITY EXPLORATION

A temporary permit may be issued once for a 180-day maximum period of time, pursuant to Nevada Revised Statutes (NRS) 445A.485, after which time the discharge shall cease or the discharger shall have applied for and received a five (5) year Permit, NRS 445A.495. A \$250.00 fee is due at the time of application, NAC 445A.232.

Area Assessment:** Specify the existing conditions at the facility (e.g. facility containment system, depth to water in the area and below each component, description of aquifer, i.e. perched, alluvial or bedrock, artesian, geothermal, etc., location of wells within 5 miles radius of project, history of the facility, any known characterization). Location of surface waters within 5-mile radius.

- 4. Narrative Description:** Site and activities that require the temporary permit (e.g. exploration details and details for continued chemical stabilization). Describe all Best Management Practices to be used at the facility, and the proposed chemical stabilization to be completed once exploration is completed. Provide all available As-built reports/drawings and surveys, as applicable that includes, but not limited to, liner system and channel design(s), tailings embankment design, stormwater diversion channel design and criteria, average and maximum heap leach pad height, approximate thickness of deposited tailings, etc,

5. **Water Quality Analysis:** Nevada-certified Lab Profile I analysis of water quality in the area (additional analysis may be required depending on the activity proposed).

6. **Exploration Activities:** The type and depth, of exploration activities, i.e. boreholes, trenches, etc., in relation to the facility geometry. The estimated maximum bulk sample to be collected at each site and total for the site/facility. If a bulk sample is to be collected, indicate the transport location. Include the UTM Coordinates (meters, NAD83) of each proposed exploration activity.

7. **Map:** Attach a pre-mining and current topographic map and a site/facility map showing the location of the proposed exploration including UTM coordinates. Include pertinent topography, water bodies, facility limits.

8. **Historic, Existing and/or pending Water Pollution Control and Reclamation Permits:** List

9. **Ownership:** The applicant must demonstrate proof of ownership of facility to be explored or demonstrated proof of authorization to explore the location prior to issuance of a permit by the Division.

Any person who knowingly makes any false statement, representation, or certification in an application, record, report, plan, or other document filed or required to be maintained by the provisions of NRS 445A.130 to 445A.730, inclusive, or who falsifies, tampers with, or knowingly renders inaccurate any monitoring device or method required to be maintained under the provisions of NRS 445A.130 to 445A.730, inclusive, or by any permit, rule, regulation, or order issued pursuant thereto, is subject to remedies and sanctions as provided in NRS 445A.675, to-wit, not more than \$25,000 per day per violation or imprisonment for not more than one year or both.
