



Solid Waste Permit/Approval Fees¹

- **Initial Issuance of a Permit or Letter of Approval Fee** – the fees are flat rate amounts for a proposed Class I or Class III landfill, a facility for the management of waste tires, and a transfer Station. Different rates apply to the landfills based on the projected tons received per day, based on an annual average.

<u>Application to Operate</u>	<u>Fee</u>
Class I site proposed to receive less than 500 tons per day	\$5,000
Class I site proposed to receive 500 or more tons per day.....	65,000
Class III site proposed to receive less than 500 tons per day.....	5,000
Class III site proposed to receive 500 or more tons per day.....	20,000
Solid Waste Transfer Station.....	1,000
Facility for the Management of Waste Tires.....	2,500

- **Annual Operating Period Permit Fee** – fee amounts are due on or before July 31 of each year. Different rates apply to the landfills based on the tons received per day, based on an annual average.

<u>Landfill Type and Activity Level</u>	<u>Fee</u>
Class I site receiving more than 100 but less than 500 tons per day ²	\$5,000
Class I site receiving 500 or more tons per day	65,000
Class III site receiving more than 20 but less than 500 tons per day.....	5,000
Class III site receiving 500 or more tons per day.....	20,000
Class III site primarily receiving by-products from the combustion of coal and receiving less than 100 tons per day.....	5,000
Class III site primarily receiving by-products from the combustion of coal and receiving 100 or more tons per day.....	10,000

- **Annual Postclosure Period Permit Fee** – applicable to solid waste disposal sites identified above.

<u>Timeframe of Postclosure</u>	<u>Fee</u>
For each year during the first 5 years of postclosure care, the fee is a percentage of the annual permit fee charged immediately preceding closure.....	50%
For each year after the first 5 years of postclosure care, the fee is a percentage of the annual permit fee charged immediately preceding closure.....	10%

- **Modification to an Existing Permit³** – these are existing permits to operate a solid waste disposal site.

<u>Modification Requirements</u>	<u>Fee</u>
If public notice and review are not required.....	\$250
If the modification requires public notice and review pursuant to NAC 444.6435, the fee is 50% of the applicable fee prescribed in the ‘Initial Issuance’ section above.....	50%

1 This fee structure was approved by the State Environmental Commission on 8 Oct, 2014, with an effective date of 24 Oct, 2014. The fee structure can be found in NAC 444.6395 as codified in August 2015.
 2 This landfill type and activity level excludes Class I sites that have received a waiver of the liner and groundwater monitoring requirements prescribed in NAC 444.681 and NAC 444.683, respectively.
 3 Routine technical corrections and administrative updates shall not be deemed to be substantive modification to permits for the purposes of charging and collecting a fee.
