DWSRF Authority and Purpose

The 1996 amendments to the Safe Drinking Water Act (SDWA) authorized the DWSRF. The DWSRF is a national program to assist public water systems in financing the cost of drinking water infrastructure projects needed to achieve or maintain compliance with the SDWA and to further the public health objectives of the SDWA. The SDWA authorizes the U.S. Environmental Protection Agency (EPA) to award capitalization grants to states that have established DWSRF programs. The Nevada Legislature passed legislation that authorizes NDEP to administer the DWSRF under the Nevada Revised Statutes (NRS) 445A.200 to 445A.295, inclusive. In addition to the authorizing statute, Nevada has adopted Nevada Administrative Code (NAC) 445A.6751 to 445A.67644, inclusive, which describes the program requirements. Federal regulations for implementing the DWSRF are found in 40 CFR, part 35. Other program directives include the Operating Agreement between NDEP and EPA, the annual Intended Use Plan, EPA guidance and policies, and conditions of each grant award.

One of the requirements of the NRS pertaining to the DWSRF is that NDEP shall not "commit any money in the account for the revolving fund for expenditure ... without obtaining the prior approval of the board for financing water projects" (NRS 445A.265(3)).

Original Commitments

Project TMWA and the City of Reno are jointly planning, designing, and pursuing the first indirect potable reuse project in Nevada, APWF at American Flat. The original SRF commitment was approved by a BFWP resolution in August of 2024.

Resolution **Conditions**

- Traditional loan shall be offered at 1.0% interest rate for the life of the loan.
- Review user rates at least every three (3) years for the life of the loan.
- The recipient agrees to draw funds available in this contract within three (3) years from the date of this contract. Funds will be subject to de-obligation and/or review after this time period by the Division.

Need for Additional Funds

The American Flat project is slated to receive a grant from the Bureau of Reclamation; however, due to changes at the federal level, the award of the grant is no longer certain. TMWA is requesting the loan authority increase to cover the potential loss of this funding.

System Infrastructure

TMWA produces 190 million gallons of water per day, that is distributed through more than 1,900 miles of water main pipeline, 93 booster pump stations, 140 pressure regulator stations, 92 storage tanks, and 2 treated water reservoirs.

Compliance

The proposed project does not address any current compliance violations. However, the project contains components of treatment for emerging contaminants, such as PFAS, pharmaceuticals, and trace constituents of emerging concerns. Therefore, the project addresses health risks before they become a compliance violation.

Language Access Plan

Recommendation

The Nevada Division of Environmental Protection (NDEP) recommends that the Board for Financing Water Projects (Board) approve the Language Access Plan.

Background Senate Bill 318 (SB318), signed into law during the 2021 Nevada Legislative Session, requires all state agencies to create a Language Access Plan (LAP) to improve access to government services, programs, and information for Nevadans with Limited English Proficiency (LEP). The Governor's Office for New Americans (ONA), with the Northern Nevada International Center (NNIC) and the University of Arizona's National Center for Interpretation (NCI), are assisting state agencies (and state Boards) to develop their Language Access Plans.

According to ONA, approximately 300,000 Nevadan's are considered LEP.

Discussion NDEP is requesting approval of the attached LAP for the Board.

- The LAP follows the template developed by the Nevada Initiative for Language Access. It contains the following elements:
 - Purpose and authority for the document
 - General policy
 - o Profile of the Board's LEP clients
 - LAP services and procedures
 - LAP implementation
 - LAP evaluation
- The Language Access Coordinator would be the Advisor to the Board.
- Staff will track the languages preferred for communication among the individuals with business before the Board.
- Staff will utilize one of the active statewide contracts for translation and interpreter services offered by the state.
- The LAP will be reviewed every six months for changes or updates.

Next Steps The LAP is due to the Governor's Office at the end of FY 2025 (June 30, 2025).

- 1. NDEP posted the LAP for 60 days for public comment, no comments were received.
- 2. NDEP is presenting the LAP at the May 2025 Board meeting for adoption.
- 3. NDEP will transmit the LAP to the Governor's Office on the Board's behalf.

LANGUAGE ACCESS PLAN NRS 232.0081

Purpose and Authority for the Language Access Plan

The Board for Financing Water Projects (Board) is required to comply with Nevada Revised Statues (NRS) 232.0081 and Title VI of the Civil Rights Act of 1964. The purpose of this Language Access Plan (LAP) is to establish protocol that the Board will follow when providing individuals with limited English proficiency (LEP).

General Policy

The Board recognizes that the population eligible to receive its services may include LEP individuals. It is the policy of the Board to ensure meaningful access to LEP individuals. The Board will adopt the following policies and procedures to ensure that LEP individuals can gain equal access to the services the Board provides and regulates.

It is Nevada's policy to grant access to services or programs to every person regardless of their ability to speak, understand, read, or write English. The Board intends to take all reasonable steps to provide LEP individuals with meaningful access to its services and programs. The Board seeks to reduce barriers by increasing its capacity to deliver services and benefits to people in their preferred languages.

The Board endorses the following policies:

- 1. The Board is committed to equity and will take all reasonable steps to provide LEP individuals with meaningful access to all its services, programs, and activities.
- 2. The Board, rather than the LEP individual, bears the responsibility for providing appropriate language services, regardless of the LEP individual's preferred language, at no cost to the LEP individual.
- 3. Staff at the initial points of contact have the specific duty to identify and record language needs.
- 4. The use of informal interpreters such as family, friends of the person seeking service, or other customers is not allowed. Minor children are prohibited from acting as interpreters.
- 5. Staff may not suggest or require that an LEP individual provide an interpreter in order to receive Board services.
