	1. The Permittee will comply with all applicable permit conditions,
	 The Permittee understands that <u>implementation of any Pollution Prevention Plan or Best Management</u> <u>Plan (BMP)</u>, will begin at the time the permittee commences work on the project,
	3. The Permittee understands that failure to submit the required fee and the original signed Certification Page within 30 days of this electronic submittal will result in failure for eligible coverage under a General Permit. The Certification Page must be printed at the end of this process; and
	4. That <u>Nevada Administrative Code (NAC) 445A</u> , requires that a Permittee (discharger) who is covered under a general permit shall pay to the Director/Division an annual services fee on or before July 1 of each year that the discharger is covered under that permit.
	5. <u>To Terminate coverage</u> of a General Permit, the Permittee must submit a Notice of Termination ("NOT") form when their facility no longer has any discharges as defined in Nevada's General Permit or EPA regulations at <u>40 CFR 122.26</u> , or when they are no longer the operator of the site.
